

## DESCRIPTION:

TopShield PRO Seam & Repair Tape is self-adhesive repair and flashing tape designed to immediately stop leaks and make a variety of roofing and waterproofing repairs. Seam & Repair Tape adheres to metal, wood, structural concrete, concrete block, brick smooth BUR, smooth SBS, smooth APP, EPDM, TPO, Hypalon and PVC roofs. Application is fast, easy and clean.

## **PREPARATION:**

Substrate should be clean, dry and free of dew, frost, oil, salt, dust and rust. Clean area first with a cloth and cleaner. On metal roofs, power wash and scrub with detergent to remove any oil or grime. Remove rust with a wire brush. Use primer on rough surfaces or in temperature below 40 °F. For best results in cold temperature application, store rolls in a warm area and warm the substrate with hot air prior to application.

## **APPLICATION:**

Cut to length. Shorter lengths (less than 4 ft) are easier to work with unless using a team of two or more applicators. Remove release film and press in place using a gloved hand or a steel roller. Apply the exact length to predetermined location. Tape cannot be pealed up and reset. Always roll from the center out to remove trapped air pockets and fishmouths. Start in corners to eliminate "tenting". Note: For Fleece Tape, coat tape the same day with TopShield PRO silicone or acrylic coating or mastic according to product instructions, a minimum of 2" beyond tape on all sides. Coating selection will depend on existing roof type and application. Always follow manufacturer application instructions and coverage rates.

### **PRECAUTIONS:**

TopShield PRO Tape will not adhere to silicone surfaces. For best results, test adhesion on membranes before application. Do NOT store at temperatures above 110 °F. Tape should not be stretched during installation. Presence of acidic or alkaline chemicals will reduce the life expectancy of tape and should be cleaned regularly.
